3 An SGA Senate Bill to make necessary changes to the Residence Council  
4 Constitution.

5 BACKGROUND: The chairs of National Residence Hall Honorary President and  
6 Residence Hall Government President(s) needed to be added as chairs in the officer  
7 list. Changes also needed to be made to make the constitution read easier.

8 Section 1. The SGA Senate hereby amends Residence Council Constitution, Article  
9 III, Section 2 as follows:

10 (1) Voting members of RC shall consist of any MWSU student living on-campus  
11 who has attended three (3) meetings of RC.

12 Section 2. The SGA Senate hereby amends Residence Council Constitution, Article  
13 III as follows:

14 (1) Voting members of RC will lose voting rights, and become non-voting  
15 members, after missing 3 consecutive meetings that are unexcused.

16 Section 3. The SGA Senate hereby amends Residence Council Constitution, Article  
17 V, Sections 1- Section 11 as follows:

18 (1) Shall be the chief executive officer within Residence Council.

19 Section 4. The SGA Senate hereby amends Residence Council Constitution, Article  
20 V, Section 5, Clause 6 as follows:

21 (1) Shall prepare and submit the annual National Information Center (NIC)  
22 report NACURH affiliation forms.

23 Section 5. The SGA Senate hereby amends Residence Council Constitution, Article  
24 V, Section 5, Clause 10 as follows:

25 (1) Shall be responsible for fundraising, when needed, for all the regional and  
26 national conferences.

27 Section 6. The SGA Senate hereby amends Residence Council Constitution, Article  
28 V, Section 5, Clause 11 as follows:

29 (1) Shall maintain Residence Council affiliation with the NACURH or its  
30 successors.

31 Section 7. The SGA Senate hereby amends Residence Council Constitution, Article  
32 V, Section 5, Clause 12 as follows:

33 (1) Shall maintain Residence Council affiliation with the Midwest Affiliate of  
34 College and University Residence Halls, MACURH, or its successors.

35 Section 8. The SGA Senate hereby amends Residence Council Constitution, Article  
36 V, Section 6, Clause 3 as follows:

37 (1) Shall be responsible for meeting with the Director of Food Services as  
38 needed.

39 Section 9. The SGA Senate hereby amends Residence Council Constitution, Article  
40 V, Section 6, Clause 4 as follows:

41 (1) Shall be the liaison between RC and the Office of Residential Life.

42 Section 10. The SGA Senate hereby amends Residence Council Constitution, Article  
43 V, Section 6, Clause 8 as follows:

44 (1) Shall work with the Residence Hall Directors to tackle current issues and  
45 resolve them.

46 Section 11. The SGA Senate hereby amends Residence Council Constitution, Article  
47 V, Section 6, Clause 10 as follows:

49 Section 12. The SGA Senate hereby amends Residence Council Constitution, Article  
50 V, as follows:

51 (1) Section 11 National Residence Hall Honorary

52 (2) Clause 1 Shall try to attend all general, officer meetings and programs for  
53 the entire duration.

54 (3) Clause 2 Shall conduct and preside over all general and officer meetings  
55 within the Griffon Gold Chapter.

56 (4) Clause 3 Shall serve as a voting member at all member and officer  
57 meetings.

58 Section 13. The SGA Senate hereby amends Residence Council Constitution, Article  
59 V as follows:

60 (1) Section 12 Residence Hall Government President(s)

61 (2) Shall try to attend all general, officer meetings and programs for the entire  
62 duration.

63 (3) Shall conduct and preside over the Residence Hall Government.

64 (4) Shall serve as a voting member at all member and officer meetings.

65 Section 14. The SGA Senate hereby amends Residence Council Constitution, Article  
66 V, Section 13, as follows:

67 (1) Residence Council Advisor(s)

68 Section 15. The SGA Senate hereby amends Residence Council Constitution, Article  
69 VI, Section 1, Letter A as follows:

70 (1) Must attend all general meetings.

71 Section 16. The SGA Senate hereby amends Residence Council Constitution, Article  
72 VI, Section 1, Letter C as follows:

73 (1) Must actively participate in at least one committee.

74 Section 17. The SGA Senate hereby amends Residence Council Constitution, Article  
75 VI, Section 1, Letter D as follows:

76 (1) Must actively participate in programming (setting up, running, and tearing  
77 down).

78 Section 18. The SGA Senate hereby amends Residence Council Constitution, Article  
79 VII, Section 1, Letter B as follows:

80 (1) If an absence problem occurs with President, a meeting shall be held with  
81 the Vice-President and Advisor. If an absence problem occurs with Vice-  
82 President, a meeting shall be held with the President and Advisor(s).

83 Section 19. The SGA Senate hereby amends Residence Council Constitution, Article  
84 VII, Section 3, Letter A as follows:

85 (1) Any member of the Executive Board is subject to be called upon for  
86 impeachment by petition of at least 10% of the voting members of RC.

87 Section 20. The SGA Senate hereby amends Residence Council Constitution, Article  
88 VII, Section 3, Letter C as follows:

89 (1) The Executive Board member shall be removed by a vote of two-thirds (2/3)  
90 of the voting membership.

91 Section 21. The SGA Senate hereby amends Residence Council Constitution, Article  
92 VIII, Section 1, Clause 1 as follows:

93 (1) RA's are required to attend three (3) meetings and three (3) programs of RC.  
94 If there is a time conflict, class or desk duty, during the meeting times the  
95 RA must let the RC Secretary know.

96 Section 22. The SGA Senate hereby amends Residence Council Constitution, Article  
97 VIII, Section 1, Clause 5 as follows:

98 (1) Each RA is required to stay for the duration of the meetings, and 30 minutes  
99 or the duration of the programs.

100 Section 23. The SGA Senate hereby amends Residence Council Constitution, Article  
101 VIII, Section 1, Clause 8 as follows:

102 (1) RC recommends that each RA try to bring residents to help build the RC  
103 community.

104 Section 24. The SGA Senate hereby amends Residence Council Constitution, Article  
105 VIII, Section 1, Clause 9 as follows:

106 (1) Each RA is responsible for writing their name on the attendance sheet and  
107 filling out and picking up and RA slip.

108 Section 25. The SGA Senate hereby amends Residence Council Constitution, Article  
109 IX, Section 1, Clause 2 as follows:

110 (1) Residence Council is not responsible for any broken items.

111 Section 26. The SGA Senate hereby amends Residence Council Constitution, Article  
112 X, Section 1, Letter A as follows:

113 (1) In order to be placed on the ballot, each candidate running for President  
114 must have a petition with their Vice-Presidential candidate signed by at least  
115 100 on campus students.

116 THEREFORE BE IT RESOLVED THAT, the senate approves changes made to the  
117 Residence Council Constitution, supported by the members of Residence Council, to  
118 review them for their legitimacy.
