



MEMORANDUM OF AGREEMENT

This Memorandum of Agreement is entered into this 1st day of September, 2019, by and between the University of Nebraska at Omaha's Athletic Training Program (Omaha, NE) and Missouri Western State University's Department of Health, Physical Education & Recreation (St. Joseph, MO).

PURPOSE

This Memorandum of Agreement that the UNO ATP and Missouri Western State University enters into permits select and qualified Missouri Western State students access to take advantage of an early review process for admission into the Master of Arts in Athletic Training offered by Graduate Studies in the School of Health and Kinesiology.

Specifically:

- Admission to the program is at the discretion of the Athletic Training Program Graduate Selection Committee in conformity with Graduate Studies standards.
- The UNO ATP agrees to hold a minimum of two (2) class seats per year in the program for Missouri Western State students who meet the application criteria set forth in this agreement, and as amended in the future.
- The UNO ATP is not required to admit any Missouri Western State student who does not meet the application criteria associated with this Memorandum of Agreement, or any future amended versions.
- The UNO ATP will communicate any changes to the application criteria annually if and when changes are made.

TERMS OF AGREEMENT

Students must meet the following criteria for preferential admission:

- Be on track to receive their degree in Physical Education from Missouri Western State University prior to enrollment for the subsequent summer semester in the UNO ATP program.
- Obtain all prerequisite coursework and receive a letter grade of "C" or better: Bio 250
 Anatomy and Physiology, BIO 101 Principles of Biology, PED 303 Kinesiology, CHE
 111 General Chemistry or CHE101 Intro to Chemistry, PED 304 Exercise Physiology,
 PED 352 Fitness and Sports Nutrition, PHY 107 Introduction to Physics or PHY 110
 College Physics, PSY 101 Intro to Psychology.

- Maintain a minimum 3.33 cumulative and prerequisite coursework GPA at the time of application and enrollment in the UNO ATP.
- Complete 25 observation hours in a clinical setting at Missouri Western State University under a Certified Athletic Trainer.
- Submit two letters of recommendation, one of which must come from a Missouri Western State University athletic training staff member.
- Complete all application materials required by the ATP and Graduate Studies at UNO.
- Complete successfully an interview with the UNO Athletic Training Program Graduate Selection Committee.

The terms of the agreement remain in force unless changed in writing by mutual agreement of both institutions. Either institution may withdraw from this Memorandum of Agreement upon six (6) months written notice, with acknowledgment that the terms of this Memorandum of Agreement shall apply to all Missouri Western State University students who, by October 1st of the year prior to summer admission before the agreement lapses, have sent a letter of intent to apply to the UNO ATP director. The agreement will be reviewed annually and amended as necessary.
