- Successful bidder shall list Missouri Western state university as additional insured.
- 4. See the attached Pre-Bid attendance sheets.
- 5. Access and set up areas will be determined with successful bidder. Any rutting in grass areas will need to be re graded by contractor at the completion of the project.
- 6. All lightning protection shall be removed and replaced. Recertification is not required.
- 7. Accidental puncture and hail damage coverage is not required.
- 8. Remove the abandoned conduit and wire on Murphy roof.
- The two canopy sections on Murphy are to be included in the work.See attached drawing.



- 10. There is no work required on the penthouse roofs at Hearnes.
- 11. The existing north RTU will be removed from Hearnes by owner. All unused equipment curbs shall be removed by contractor.
- 12. The three satellite dishes on Hearnes will be removed by owner. All equipment curbs shall be removed by contractor.
- 13. The RTU's on the east half of Hearnes do not need to be re flashed.
