- Audit is being completed.
- FAFSA opened October 1, 2016.
- Physical Plant is back to normal after summer and the opening, remodeling and renovating of campus locations. This is a hectic week for event planning due to Homecoming activities.

Report of Jerry Pickman:

- Several Homecoming activities through the Alumni Office, Student Affairs and Athletics are planned for this week.
