Staff Association President Tara Stoll called the meeting to order.

## Report of Dr. Jeanne Daffron by Dr. Doug Davenport:

- Draft report to Commission from HLC Team about MWSU was positive with no surprises. Dr. Davenport is fact checking the seventy-four page report and will then submit to the Commission.
  - The Institutional Actions Council will vote whether accreditation should be continued. Dr.
     Davenport has confidence in the eventual outcome.
- Commencement will be December 17, 2016 at 11am.
  - o Any volunteers are welcomed and appreciated.
  - o Any staff that has regalia is welcome to march.

# Report of Dr. Cale Fessler:

- HR:
  - Fair Labor Standards Act (FLSA) changes to exempt/non-exempt status Sally is having meetings with all supervisors on campus. She will contact employees affected by the change and they will receive training for time report submission, etc. For now, they will remain on monthly payroll.
  - o Open enrollment deadline: November 11, 2016.
- Power issues on campus: they are not originating here, but around us. Talks are being held about power backup in Hearnes' server room.
- Missouri Dept. of Higher Ed. (MDH) has received updates about House Bill 19 projects.
- Potter: \$150,000 appropriation from state and \$150,000 from the Foundation has been committed for the architectural design of Phase 1. The firm will be announced soon. Efforts with this company will begin soon after.
- With a new governor being elected, MWSU is monitoring his interests.
- Question from Tara Stoll: have we received the Great Colleges to Work For survey results?

o Response from Dr. Davenport: Yen To, Director of Assessment has the results and is working through/reviewing the open ended comments. She will distribute once finished.

# Report of Dr. Robert Vartabedian:

- Mystics and Band members have taken a knee during the National Anthem at recent MWSU events.
  This caused a stir with some alum and benefactors. A couple have sent letters announcing the finality of
  their continued support. Dr. Vartabedian shared that MWSU has no choice. Everyone has a right to nonviolently expressing themselves. The Mystics have said they will continue through basketball season.
  While there is a concern due to the potential of veterans being present, the University still has to and will
  allow the freedom of expression.
- Training Camp meeting: future negotiations will not be as much as in the past. The city, county and CVB representatives are aware.
- Cronkite: The November 4 private and November 5 public celebrations of his birthday went well.
- Potter: Phase 1 of the architectural plan is moving forward.
- Enrollment consultants: have exceeded expectations with current fall enrollment and prospective student visitors.
- Daycare on Campus: YMCA has had their people and equipment on our campus for several years. Currently, there is small interest and the relationship is coming to an end. In the future, Student Affairs might handle the effort in house.
  - Question from Jessica Frogge: when is the last day for the daycare? Cale responded that there is no one there currently. It has been empty through the summer and fall. The contract expired in October. Dr. Vartabedian spoke to the SGA President and wanted to mention it to the Student Senate. Barb Harris asked if it could be a Lab School. Dr. Vartabedian said that is a possibility down the road. Dr. Vartabedian reported that students and employees had been informally surveyed and there is no current interest.
- Outcome of last night's elections: The governor's race affects us the most. Greitens is a wild card as governor. He can help or hinder our progress. Trump/Clinton indirectly affects us. With the new administration, programs on campus could be shut down. An example would be Title IX. Kander/Blunt Blunt is close to the University. As a Republican, he might reinstate earmarks. This could work to our advantage.
- Tara Stoll thanked Dr. Vartabedian on behalf of the staff for the additional holiday break days. Dr. Vartabedian expressed his appreciation and said that was the least he could do for everyone.

### Report of Jerry Pickman by Colleen Kowich:

- Homecoming was successful and the Black Alumni Homecoming was very successful. A new event this year was having the younger Future Griffs dress as superheroes and princesses. This was a lot of fun and will continue. Two hundred Alumni t-shirts and two hundred Future Griffs t-shirts were handed out.
- Arts Society: Dr. Susan Carter's Opera Workshop performed segments from *Ragtime* at the Society's annual meeting.
- Donors: received Foundation Report last week
- What's In a Name: naming opportunities on campus initiated by Dr. Vartabedian will go out soon.
- Database upgrade: moving from traditional to a hosted program. This will allow online event registration and will be mobile friendly. Online giving apps will allow for multiple staff users and will be more customer friendly.

• 2017 Solar Eclipse: will be in August 2017. St. Joseph will be able to see it quite well. Jomel Nichols, Kendy Jones, Patty Kuechler and Amanda Morrow are MWSU representatives on the community committee.

### **Report of Shana Meyer:**

- There was a campus watch party for last night's election with seventy-five students in attendance. Busses took students to the polls for voting. It was heartening to see so many students and they were rooting for both candidates.
- Counseling Center: post-election stress some were referred from their classes. Some feel fear. Perception is legitimate.
- Proposal: SGA at Mizzou is asking for Missouri legislators to fund \$2 million to increase counseling staff. One counselor/five hundred students is being proposed. They are asking for \$50,000 to be allocated to MWSU.
- Veterans: activities in Blum this week. There is concern that we are not closed for Veterans' Day.
- RFP for food service contract: Aramark expires in May. It is hopeful to have a decision by the February Board Meeting.
- Food/Coat Drive: will be held November 14-18 in Blum.
  - O Question from Carol Hare: will that be a drive for our students? Shana responded yes. Any that are not distributed will go out to the community.
