Report of Dr. Daffron

Report of Mr. Fessler

- 1. Retroactive salary adjustments (3%) were done in September. Communication from Human Resources will follow on the re-issuance of contracts.
- 2. Board of Governors approved the health insurance providers for 2014 at the September Board Meeting. Blue Cross Blue Shield rate increased by 2.5%.
- 3. The ancillary benefit lines have increased benefits with a move from Aetna to Prudential, particularly life insurance related.
- 4. Annual Audit will be presented to the Board of Governors for approval at the October Board Meeting.
- 5. The campus maintenance issues list was discussed with Lonnie Johnson. Johnson and his staff reviewed the listing in detail. Issues ranged widely from small-scale single building issues to large-scale issues of building renovation or campus wide projects. Physical Plant, will address many of the maintenance related issues such as building and furniture cleanliness. Some of the larger issues, such as the Wilson and Potter Restrooms, will be addressed through Reserve Funds. Some of the major renovation projects are outside of MWSU's ability to undertake at this time.
- 6. Griffons Nest is finishing up. Sod for the area is being laid on October 8.

Report of Dr. Grimes (for Ms. Meyer)

- 1. October 11 will be busy with a soccer game, Homecoming bonfire and fireworks.
- 2. There are many opportunities to tailgate before football games. Some tents that are set up are the President's, sororities and fraternities.
- 3. The Career Fair is October 29 in the Fulkerson Center.
- 4. Amy McLarren is appointed as the Interim Director of Residential Life.

Report of Ms. Sanders

- 1. Contracts and non-exempt employee letters will be delivered soon. Those employees who did not sign a confidentiality agreement in August will be sent an additional copy to sign with their new letters.
- 2. Board of Governors approved the health insurance providers for 2014. Blue Cross Blue Shield will remain the health insurance carrier, VSP as the vision insurance carrier, Delta Dental replaced BCBS for dental insurance, and Prudential will be the ancillary insurance provider.
- 3. Open Enrollment is scheduled for October 30 and 31. Misty Miller will send out an e-mail to all employees with details. The Flu Shot Clinic will be available during open enrollment.
- 4. Employees may enroll for the 2014 health benefits by way of the call center or online enrollment.

Question: will financial vendors be present at open enrollment? Answer: no, financial vendors will be present at the wellness screening during the spring.

Question: will the HSA medical insurance be available during 2014? Answer: yes.
